

2014 Billingsley Ford SWRHA Futurity & Show Terms and Conditions

- 1. Futurity is open to three-year-old horses of any breed.
- 2. There are nine divisions of the SWRHA Futurity Level 4 Open, Level 3 Open (Int. Open), Level 2 Open (Ltd. Open), Level 1 Open, Level 4 Non Pro, Level 3 Non Pro (Int. Non Pro), Level 2 Non Pro (Ltd. Non Pro), Level 1 Non Pro, and Prime Time Non Pro (50+). The Level 4 Open division is open to any contestant. The Level 3 Open, Level 2 Open, Level 1 Open, Level 4 Non Pro, Level 3 Non Pro, Level 2 Non Pro and Level 1 Non Pro eligibility will be based upon the Year 2013 NRHA Category 2 Class eligibility list. Each individual is responsible for his or her correct class eligibility.
- 3. Horse and rider MUST be named at time of entry.
- 4. All Futurity entries will be required to enter the division above the division they originally enter. (If entering the Level 2 Open Futurity you must also enter the Level 3 Open, Level 3 Open must also enter the Level 4 Open. The same rule applies in the Non Pro Futurity, including the Prime Time Non Pro.)
- 5. Nomination fees plus judges fees must accompany entry forms.
- 6. Owner and riders must be current members, in good standing, of the NRHA. Copies of NRHA Competition License and NRHA membership cards for owner and rider MUST accompany entries. Both owners and riders must be members of the SWRHA to receive merchandise awards in each futurity division.
- 7. Entries must be RECEIVED on or before October 1, 2014 to avoid any late fees. Postmarks do not count. A penalty of \$100 plus all regular entry fees will be charged for entries received after October 1, 2014.
- 8. The draw <u>closes</u> on 9 am <u>Monday</u>, <u>October 20, 2014</u> for the <u>John Deere Open Futurity</u>. Entries received after October 1 but before 9 am Monday, October 20 will pay a late fee but will be included in the regular draw. The draw for the Open Futurity will be posted after 2 pm on Monday, October 20. Post entries for the Open Futurity will be accepted until 4 pm Tuesday, October 21 and will be placed in a group preceding the regular draw.
- 9. The draw <u>closes</u> on 9 am <u>Wednesday</u>, October 22, 2014 for the <u>Red River Equine Vet Services Non Pro Futurity</u>. Non Pro Futurity entries received after October 1 but before 9 am Wednesday, October 22 will pay a late fee but will be included in the regular draw. The draw for the Non Pro Futurity will be posted after 2 pm on Wednesday, October 22. Post entries for the Non Pro Futurity will be accepted until 4 pm Thursday, October 23 and will be placed in a group preceding the regular draw.
- 10. Divisions may be added or changed without penalty prior to noon the day of each draw. In the event division changes result in differences in entry fee requirements, no refunds will be granted, but any additional fees owed must be paid to compete.
- 11. There will be NO REFUNDS for Futurity entries.
- 12. Substitutions will be permitted with a \$50 penalty after October 1 until post entries close for each division.
- 13. For the Level 4 Open, Level 3 Open, Level 2 Open and Level 1 Open divisions there will be a first go and a finals. The number of horses taken back to the finals will be based on the NRHA placings per number entered (per NRHA payback schedule B) plus 7 additional entries. 100% of the purse will be paid in the finals. All places in the finals will receive a check.
- 14. For the Level 4 Non Pro, Level 3 Non Pro, Level 2 Non Pro, Level 1 Non Pro and Prime Time Non Pro divisions there will be one go. 100% of the purse will be paid in this go, according to NRHA payback schedule B percentages.

- 15. There will be a Mare Bonus of \$1,000 in the Futurity in the Level 4 Open and Level 4 Non Pro. There is no additional entry required. All mares entered in the Level 4 Open division and Level 4 Non Pro division of the Futurity are eligible. The mare bonus for the Level 4 Open futurity class will be awarded to the highest placing mare in the finals. Should a mare not advance to the finals, the bonus will be awarded to the highest placing mare in the preliminaries. The mare bonus for the Level 4 Non Pro futurity class will be awarded to the highest placing mare.
- 16. Prize money for all divisions will consist of the respective total entry fees received, less a 40% retainage, plus the added money. All late fees and substitution fees will be added to the purse.
- 17. All decisions of the judges are final. Three judges will judge the SWRHA Futurity with all scores being used.
- 18. All exhibitors will be subject to the use of photographers and videographers under the direction of show management for the benefit of show promotion. No exhibitor will be allowed the discretionary use of their services.
- 19. Sponsor and Futurity entry Paid Warm-ups will be scheduled and riders will be notified of date and approximate time. All other Paid Warm-ups may be reserved by phone (580-759-2929) or fax (580-759-3999) as available beginning at 8 am on Tuesday, October 7.

General Show Conditions

- 1. Ancillary class entries must be received by October 1, 2014. Entries received after October 1, 2014 will be subject to a \$40 penalty per horse. Ancillary class entries close at noon the day prior to the class. All ancillary class draws will be posted at 5p.m. the night before the class runs. Entries received after the class closing will compete in a group preceding the regular draw. The exception to that is in the Rookie Level 1 & 2 and the Limited Non Pro class on Sunday, October 19, in which all entries received after the class closing will compete in a group at the end of the regular draw.
- 2. Scratched ancillary entries will be refunded, all entry fees minus late fees, if scratched prior to the draw. No refund for ancillary entries after the draw is complete.
- 3. STALLS: Move in will be available no earlier than 8 am, Thursday, October 16. Stalls reserved only with payment in full, due October 1. ALL HORSES MUST HAVE A STALL OR DAY FEE. If you want to stall with someone, all fees and reservations must be sent together. If reservations and monies are not received by October 1, only limited stalls will be available on a first-come, first-served basis. STALLS ARE LIMITED! Paid reservations are critical. See Stall Reservation Form for details. Office must be notified of stall cancellations in writing. There will be no refunds on cancelled stalls after October 1. Shavings will be available.
- 4. WARM UPS: Paid warm ups are available Thursday thru Monday. All futurity entries will be entitled to one slot per horse and each warm up MUST be ordered and pre-paid with entry forms. Absolutely no guarantees unless pre-paid. Sponsors will be given priority in paid warm up placement. Non-futurity entry warm up reservations will be accepted on a first come, first served basis.
- 5. NSF CHECKS: All checks returned by the bank as insufficient, MUST be replaced with cash, money order or cashier's check, plus a \$30 service charge. If the payment was a futurity entry and the replacement money was not received by October 13 a late fee of \$100 will also be assessed. Any NSF not cleared up within ten days after the end of the show will result in immediate suspension from the SWRHA and the check will be turned over for appropriate action with the giver responsible for all additional costs incurred by the SWRHA. Failure to pay outstanding balance owed will result in a report being given to NRHA.
- 6. MEMBERSHIP: Owner and riders must be current members, in good standing, of the NRHA. Current membership cards or a photocopy must be shown with each entry. Owners and riders must be members of the SWRHA to receive merchandise awards in each ancillary class.
- 7. NRHA COMPETITION LICENSE: All horses competing in NRHA classes must have an NRHA Competition License. The original or a photocopy MUST be shown with all entries. NEGATIVE COGGINS ARE REQUIRED.
- 8. PAYBACKS: Payback monies will be made according to NRHA payback schedule. Show retainage is 50%.
- 9. Dogs are welcome but <u>must</u> be on a leash. There will be a \$10 fine for unleashed dogs per occurrence.
